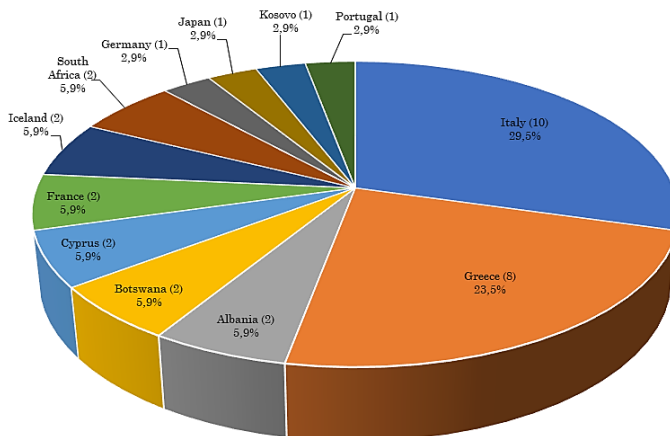


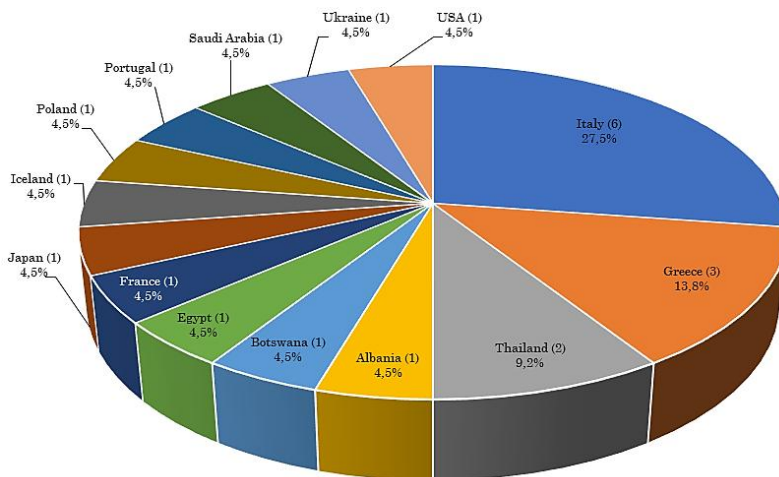

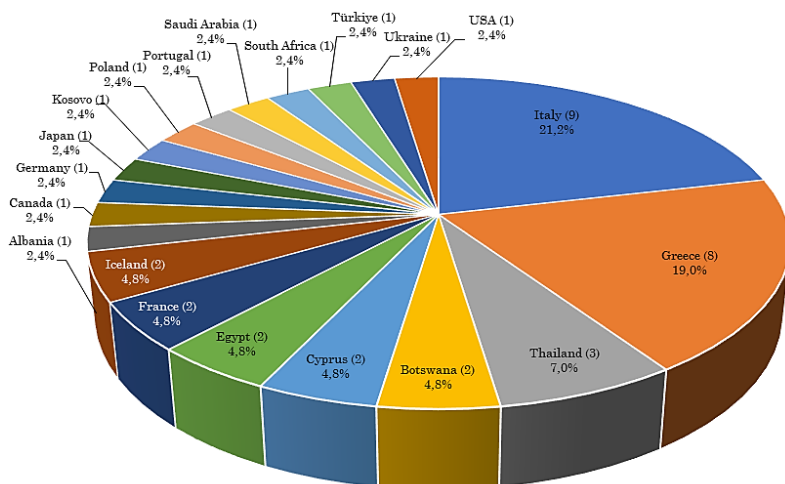
#### Conference forum presentations authorship — geographical representation



#### Conference forum comments authorship — geographical representation

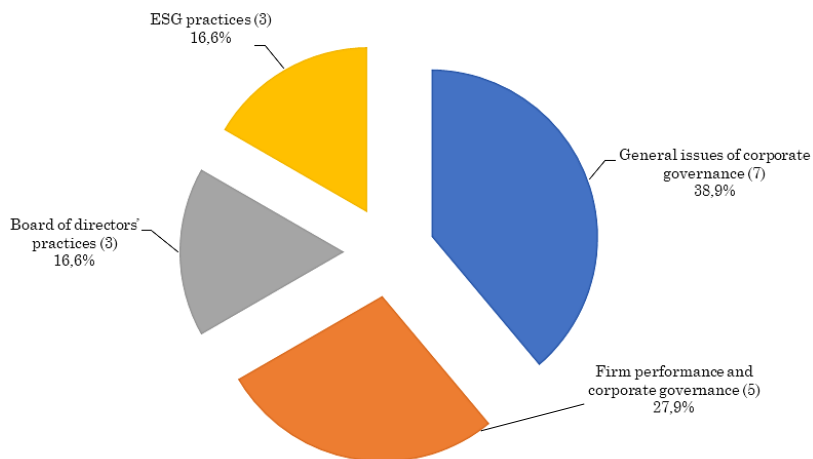


### Conference forum attendees — geographical representation

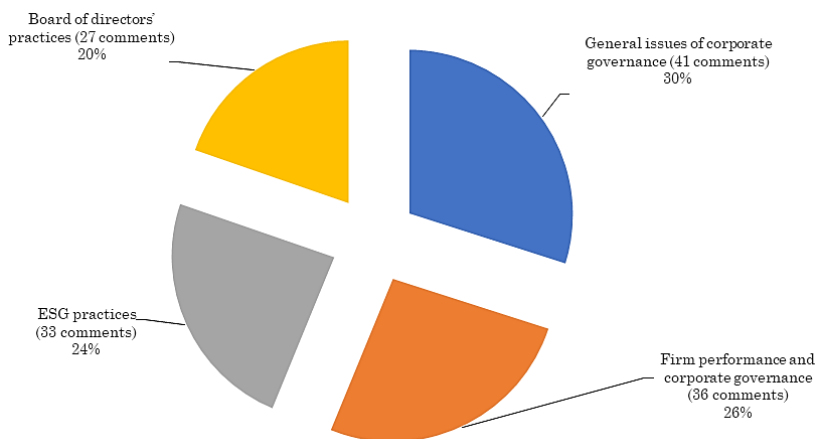

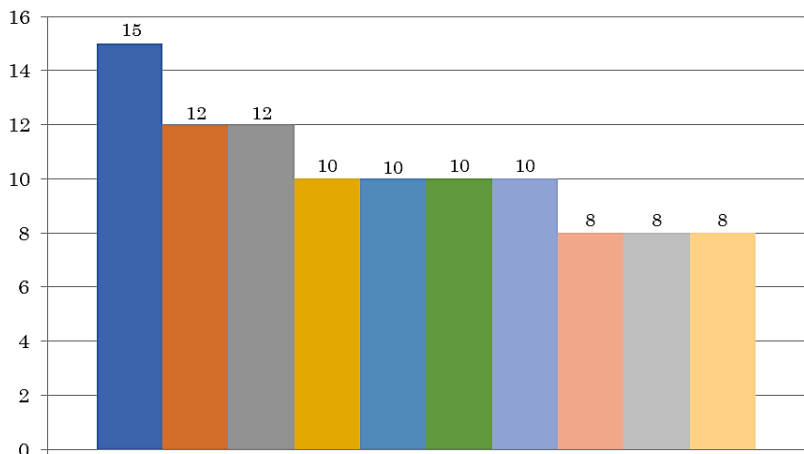
### Topics of the conference forum presentations

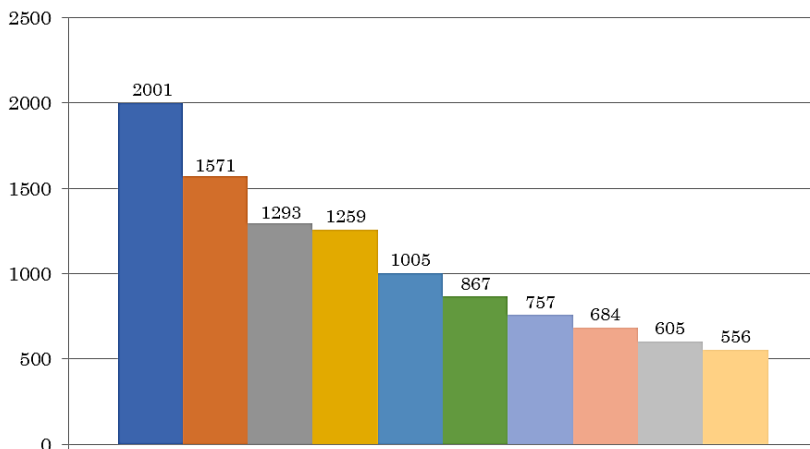

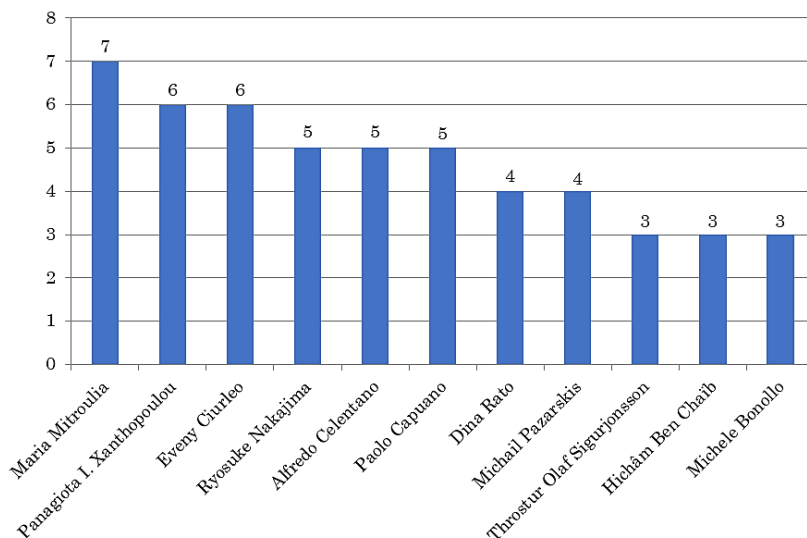
